#### **RACE 1: HYGAIN PAK-CELL C,G & E MAIDEN HANDICAP**

**1000M**

**Stephan** – Raced wide throughout. Laid in over the final 200m.

**Withorn** – Slow to begin.

**Alfstar** – Slow to begin. Passing the 250m was eased from the heels of Breezesun (M Cahill) which shifted out when not quite clear. M Cahill was advised to exercise more care. When questioned rider R Brewer stated that his mount made a respiratory noise throughout the event upon pulling up. A post-race veterinary examination of the gelding revealed it to be making a respiratory noise. Trainer Mr W Hudd advised that the gelding would now undergo a respiratory procedure prior to racing again.

#### **RACE 2: HYGAIN RACETORQUE F & M MAIDEN HANDICAP**

**1000M**

**Uno Eyno** – Trainer Ms T Bateup was fined the sum of \$100 under LR35 for the late declaration of app R Dolan as the rider of the filly.

**Tawfic Girl** –Became fractious in the barriers, reared and struck its head on the barrier stall superstructure sustaining an abrasion to its head and was a late withdrawal on veterinary advice at 1:44pm. Stewards ordered all investments on Tawfiq Girl be refunded in full and further that all successful bets placed with bookmakers placed prior to 1:44pm be paid subject to the following deductions in the dollar on the face value of the ticket:

1<sup>st</sup> **Star Of The Clan**: 5c win and 5c place

2<sup>nd</sup> **Stratum's Rose**: 7c place

3<sup>rd</sup> **Exceptional Rythm**: 8c place

At a subsequent inquiry stable representative Ms R Fowler was advised that the filly would be required to barrier trial to the Steward's satisfaction prior to being permitted to race again.

Stratum's Rose – Slow to begin. Raced greenly in the straight and passing the 250m shifted out abruptly.

**Uno Eyno** – From its wide draw was obliged to race very wide throughout.

**So Foxy** – Raced wide throughout.

**Zarlana** – Raced wide throughout.

**RACE 3: HYGAIN RELEASE CLASS 1 HANDICAP 1200M**

**Cafe Terrace** – As M Travers was overweight, Stewards permitted R Bensley to be substituted as the rider of the gelding. M Travers was fined the sum of \$200 (AR120(b)).

**Pink Moscato** – Trainer Mr R Potter was fined the sum of \$200 under AR59A for failing to produce the Thoroughbred Identity Card for the mare. Mr Potter was further advised that the mare would not be permitted to race again until such time that the Thoroughbred Identity Card is produced.

**Lessyd** – Slow to begin.

**Confidential** – Slow to begin.

**Taqueada** – Slow to begin.

**Living Doll** – When questioned, rider R Brewer stated that his mount began awkwardly, was then slow to muster speed and settled further back than anticipated. He further added that whilst the filly was three wide it had the benefit of cover but did not travel at any stage of the event and proved disappointing in its failure to respond to his riding in the straight. A post-race veterinary examination of the filly did not reveal any abnormality.

**Trumbo** – Raced wide throughout.

**Suneeze** – Over-raced for some distance joining the course proper at the 1000m. A post-race veterinary examination of the mare did not reveal any abnormality.

**Keep Me Posted** – Raced wide throughout.

**RACE 4: HYGAIN RECUPERATE MAIDEN HANDICAP 1400M**

**Mini Model** – Slow to begin. Rider N Barzalona pleaded guilty to a charge under AR145 of having returned to scale in excess of ½ kg above his mount declared weight. N Barzalona was fined the sum of \$300. In assessing penalty Stewards took into consideration N Barzalona's unblemished record in respect to breaches under the Rule and also the beaten margin of a head between his mount which was placed fifth and Kianga which was placed fourth.

**Zafox** – Slow to begin.

**Kianga** – Passing the 200m was brushed by Mini Model which laid in under pressure.

**RACE 5: HYGAIN TRACKTORQUE CLASS 1 & MAIDEN PLATE** **2000M**

**Fallada** –Became fractious in the barriers, reared and struck its head on the barrier stall superstructure and was a late withdrawal on veterinary advice at 3:31pm. Stewards ordered all investments on Fallada be refunded in full and further that all successful bets placed with bookmakers placed prior to 3:31pm be paid subject to the following deductions in the dollar on the face value of the ticket:

1<sup>st</sup> **Savvy Ken**: 1c win and 0c place

2<sup>nd</sup> **Kuiper Belt**: 5c place

3<sup>rd</sup> **Counterfire**: 9c place

At a subsequent inquiry stable representative Mr L Hodgson was advised that the gelding would be required to barrier trial to the Steward's satisfaction prior to being permitted to race again.

**Everly Girl** – Slow to begin. Raced wide throughout.

**Professor Marvel** – Bumped on jumping by The Potato Pontiff which shifted out.

**The Potato Pontiff** – Over-raced in the early and middle stages.

**Roc Sands** - Rider R Bensley pleaded guilty to a charge under AR145 of having returned to scale in excess of ½ kg above his mount declared weight. R Bensley was fined the sum of \$150.

**RACE 6: TAB FEDERAL BENCHMARK 55 HANDICAP** **1000M**

**Damagic** – Became fractious in the mounting enclosure became momentarily cast on the enclosure fence and sustained a deep laceration to its groin area and was a late withdrawal on veterinary advice at 4:00pm. The start was delayed when the gelding required veterinary treatment. Stewards ordered all investments on Damagic be refunded in full and further that all successful bets placed with bookmakers placed prior to 4:00pm be paid subject to the following deductions in the dollar on the face value of the ticket:

1<sup>st</sup> **Waldo Walorf**: 5c win and 7c place

2<sup>nd</sup> **Zambada**: 5c place

3<sup>rd</sup> **Seduction**: 7c place

At a subsequent inquiry co-trainer Mrs B Joseph was advised that a veterinary clearance would be required prior to the gelding also having to barrier trial to the Steward's satisfaction prior to being permitted to race again.

**Kapaonik** – Slow to begin. A post-race veterinary examination of the mare did not reveal any abnormality.

**The Last Sommet** – Slow to begin.

**It's Business Time** – Raced wide throughout.

**Lulu Raez** – Raced wide throughout.

**Zambada** – Slow to begin.

**Aussie James** – When questioned, rider J Penza stated that his mount which was resuming without the benefit of a trial weakened inside the final 200m under its big impost of 64kg. A post-race veterinary examination of the gelding did not reveal any abnormality.

**RACE 7: HYGAIN MICRSPEED BENCHMARK 55 HANDICAP 1400M**

**More Than Tears** – Raced wide throughout.

**Napayshani** – Was not tested close to the line when awkwardly placed on heels.

**Summary of whip use:**

Stewards noted the following riders exceeded the permitted strikes of the whip prior to the 100m under AR137A(5)(a)(ii) or on consecutive occasions under AR137A(5)(a)(i). Bearing in mind the totality of whip use, no action was taken.
