

## STEWARDS REPORT

### Tottenham Picnic Race Club TOTTENHAM RACECOURSE

#### **Race 1: Class 3 Trophy 800m:**

**Mi Estilo** – late withdrawal at 1.08pm acting on veterinary advice.

**Redaktor** – slow to begin.

**Captain Archie** – late withdrawal at 1.59pm after becoming fractious behind the barriers and rearing over. Stewards subsequently ordered all monies wagered on *Captain Archie* be refunded in full and all successful wagers placed with bookmakers prior to 1.08pm be subject to the following deductions in the dollar on the face value of the ticket:

First: *Bulbadah* less 2 cents win and 3 cents place; and

Second: *Ace Lightning* less 4 cents place.

Trainer Mr. J. Tyack was advised that the mare would be required to barrier trial to the satisfaction of stewards before being permitted to race again.

#### **Race 2: Maiden Plate 1000m:**

**Wake Up Cass** – slow to begin.

**Buster's Princess** – overraced in the early stages.

#### **Race 3: Picnic Trophy 1000m:**

**Spirited Addition** – a post-race veterinary examination did not reveal any significant abnormalities.

#### **Race 4: Class 1 Handicap 1200m:**

**Future in Doubt** – jumped awkwardly.

**Snow Moon** – a post-race veterinary examination did not reveal any significant abnormalities.

**Coop 'n' Demp** – rider R. Wilson was fined \$100 (AR137(c)) for making a celebratory gesture prior to the winning post.

**Daliapour's Beauty** - slow to begin.

**Mossbridge** – a post-race veterinary examination did not reveal any significant abnormalities.

#### **Race 5: Tottenham Picnic Cup 1400m:**

**Lakota Sioux** – slow to begin (2L).

**Northern Myth** – a post-race veterinary examination did not reveal any significant abnormalities.

**Tainos** – slow to begin (3L).

**Edge of Madness** - steadied near the 50m when crowded by *Double Halo* (R Blewitt) which shifted out under pressure. R Blewitt was reprimanded AR137(a).

**Race 6: Class B Handicap 1400m:**

**Hart Burn** – shortly after the start, ran in abruptly and dislodged rider M. Wade. M. Wade was uninjured. *Hart Burn* then escaped the confines of the racecourse and sustained some minor lacerations and abrasions before being captured. Stable representative Mr. D. Jeffries was advised *Hart Burn* would be required to barrier trial to the satisfaction of the Stewards prior to racing again.

**I Love Ida** – a post-race veterinary examination revealed the mare to have bled from both nostrils for the second time. Trainer Mr. R. Robb was advised the mare would now incur a lifetime bar from racing in Australia under the provisions of AR53A; Stewards permitted rider Ms. M. Wright to ride the mare half a kilogram overweight; Ms. M. Wright was reprimanded (AR120(b)).

**Unkapped** – rider Ms. T. Lannstrom will be interviewed relative to her weighing out without irons and stirrup leathers and leaving the course without permission.

**Olive Beauty** – hampered by the riderless *Hart Burn* in the early stages, losing considerable ground.

**Cream of Oz** – hampered by the riderless *Hart Burn* in the early stages, losing considerable ground.

**General:**

Samples were obtained from four riders, which will be forwarded to the Australian Racing Forensic Laboratory for testing for substances banned under AR81B.

Stewards adjourned an inquiry into an incident involving two riders in the jockey's room following the running of race 5.

Samples were obtained from **all** winners.
