

## STEWARDS REPORT

### Grenfell Picnic Race Club GRENFELL RACECOURSE

Saturday 14th April 2018

Weather: Fine.  
Track: Good (3).  
Rail: True.

#### **Race 1: Maiden Plate 1000m:**

**Deadly Cute** – over-raced during the middle stages.

**Illourie Arch** – laid out when placed under pressure over the concluding stages.

**Nightinn** – late withdrawal at 1:27pm when the gelding refused to load into the barriers after several attempts. Stewards subsequently ordered all monies wagered on *Nightinn* be refunded in full and all successful wagers placed with bookmakers prior to 1.27pm be subject to the following deductions in the dollar on the face value of the ticket:

First: *Deadly Cute* less 0 cents win and 12 cents place and;

Second: *Illourie Arch* less 16 cents place.

Stable Representative Mr. G. Wright was advised *Nightinn* would now be required to barrier trial to the satisfaction of the stewards prior to racing again.

**More Cheers** – held up for clear running approaching the 200m and near the 150m was shifted out to continue into clear running.

#### **Race 2: Picnic Bracelet 1000m:**

**Hyacintha** – jumped awkwardly; was steadied away from the heels of *Layo Layo* passing the 700m.

**Layo Layo** – laid in passing the 150m.

**Long Lasting** – jumped awkwardly. Rider S. Fogg was fined the sum of \$100 under AR137(c) for making a celebratory gesture prior to the winning post.

**Raheen Lady** – buffeted on jumping between *Hyacintha* and *Long Lasting*. As no other suitable rider was available, permission was granted for M. Wade to ride the mare 0.5 kilograms overweight. M. Wade was fined the sum of \$50 under AR120(b).

**Lightning Alert** – was steadied from the heels of *Heeby Frenly* passing the 700m. A post-race veterinary examination revealed the gelding to have bled from both nostrils for the first time. Trainer Mr. T. Sutherland was advised the gelding would now incur a 3 month ban from racing in Australia under the provisions of AR53A.

**Heeby Frenly** – over-raced in the early stages.

**Oh No Gecko** – Trainer Mr J. Tyack was advised a warning would be recorded against the gelding for a poor performance.

**Race 3: Maiden Plate 1200m:**

**All Good** – laid in passing the 150m.

**One Eye Watching** – slow to begin; was steadied away from the heels of *All Good* which shifted in shortly after jumping.

**Belava Brooke** – approaching the 100m, was steadied away from the heels of *Experienced* (R. Blewitt) which shifted out under pressure. R. Blewitt was advised to exercise more care.

**Race 4: Class 2 Trophy Handicap 1200m:**

**Tearful Kitty** – laid in passing the 100m.

**Choppa** – shortly after the start, the gelding commenced the buck for a considerable distance and was restrained out of the event. Stable Representative Mr G. Wright was advised *Choppa* would now be required to barrier trial to the satisfaction of the stewards prior to racing again.

**Prisonbreak** – passing the 100m, ran in abruptly and had to be straightened. Rider Ms. T. Lannstrom was reprimanded under AR137A(4)(c) for using her whip when her mount was out of contention.

**All Rounder** – slow to begin; raced wide without cover.

**Senoritaville** – slow to begin.

**Race 5: Grenfell Picnic Cup 1400m:**

**Lulu's Destiny** – over-raced in the early stages; raced wide without cover. A post-race veterinary examination revealed no significant abnormalities.

**Rehanaat** – hung out rounding the home turn.

**Malibu Stacy** – slow to begin.

**Race 6: Class 1 Trophy Handicap 2000m:**

**Princess Strada** – hung out passing the 1700m.

**Stefanya** – a post-race veterinary examination revealed no significant abnormalities.

**Maralto** – slow to begin; raced wide without cover.

**Tumbleweed** – passing the 600m, laid in and away from *Princess Strada*, making contact with the running rail. Rider Ms. P. Mills was reprimanded under AR137A(5)(a)(ii) for using her whip on 9 occasions prior to the 100m.

**Lens** – jumped awkwardly, resulting in the rider becoming unbalanced and the gelding losing considerable ground on the field.

**General:**
