## Race 1: Class 2 Handicap 1600m:

**Algeroba** – held up in the early part of the straight and was shifted out to continue into clear running.

A Good Yank – slow to begin.

Sissie's Choice - slow to begin.

**Henny's Harmony** – raced wide throughout.

**Snipex Abaa** – hampered on jumping.

Will She Appeal – raced wide throughout.

**Decades** – hampered on jumping.

**Jonah Hex** – slow to begin.

## Race 2: Maiden Plate 1500m:

**Carinda Road** – attempted to buck in the early stages; Trainer Mr. C. Lundholm was advised a warning would be recorded against *Carinda Road*; raced ungenerously in the early and middle stages; a post-race veterinary examination did not reveal any significant abnormalities.

**Irish Spy** – underwent a pre-race veterinary examination and was passed fit to start; raced wide throughout.

**Passionate Prince** – crowded on jumping; checked near the 1200m when the pace slackened slightly.

**Starlight Treaty** – raced wide throughout; a post-race veterinary examination did not reveal any significant abnormalities.

**Glitterane** – Trainer Mr. M. Mulholland was fined \$100 (AR140A) for presenting *Glitterane* with the incorrect gear.

#### Race 3: Class 2 Handicap 1500m:

**Viva Lavino** – crowded on jumping; laid out under pressure in the straight.

**Stars And Stripes** – raced wide throughout; a post-race veterinary examination did not reveal any significant abnormalities.

**Dragons Mistake** – crowded on jumping.

**My Valore** – crowded on jumping.

# Race 4: Maiden Handicap 1200m:

**Gerrylarose** – raced wide throughout.

Our Boy Tiggy – ran in abruptly near the 1100m.

**Supreme Confidence** – slow to begin; raced wide throughout.

Naretha - raced wide throughout.

**Dreamworthy** – a post-race veterinary examination did not reveal any significant abnormalities.

**Friskee As** – a post-race veterinary examination did not reveal any significant abnormalities; beaten 22.19 lengths; Trainer Ms. K. Kennedy was advised a warning would be recorded against *Friskee As*.

## Race 5: Mendooran Cup 1200m:

Grass Cutter – began awkwardly.

**Emo Girl** – steadied near the 700m when *Mr De Niro* laid in and away from *Grass Cutter*.

**Mr De Niro** – steadied near the 100m when crowded between *Emo Girl* (App. Ms. W. Peel) and *Zatigeroo* (App. J. Gibbons), both of which shifted ground under pressure. Both App. Ms. W. Peel and App. J. Gibbons were reprimanded (AR137(a)).

Strike Zone – slow to begin.

**Black Salt** – slow to begin; the saddle shifted back throughout the event, placing rider App. Ms. K. Bell-Pitomac at a disadvantage.

## Race 6: Benchmark 50 Handicap 1000m:

**Ceaseless** – slow to begin.

**Special Silk** –underwent a pre-race veterinary examination and was passed fit to start; a post-race veterinary examination did not reveal any significant abnormalities; beaten 22.92 lengths; Trainer Ms. C. Chapman was advised a warning would be recorded against *Special Silk*.

Raheen Lady – raced wide throughout.
